In the pursuit of school-wide excellence we aim to provide the opportunity for all of our pupils to reveal, display and extend their God-given talents and abilities. Supporting the needs of the individual is crucial in raising the achievements for all. Driven by the belief that the potential to realise and demonstrate gifts and talents is not exclusive to some, but to all, pupils are encouraged to take ownership of their learning to ensure that they are able to recognise and apply their unique gifts and talents to reach their full potential.

The Pupil Premium Grant was introduced in April 2011 to provide funding for two policies:

- raising the attainment of disadvantaged pupils and closing the gap with their peers
- supporting children and young people with parents in the regular armed forces

The PPG per pupil for 2015 to 2016 is as follows:

- £1,320 Pupils in year groups reception to year 6 recorded as Ever 6 FSM
- £1,900 Looked-after children (LAC) defined in the Children Act 1989 as one who is in the care of, or provided with accommodation by, an English local authority
- £1,900 Children who have ceased to be looked after by a local authority in England and Wales because of adoption, a special guardianship order, a child arrangements order or a residence order
- **£300** Pupils in year groups reception to year 11 recorded as Ever 5 Service Child or in receipt of a child pension from the Ministry of Defence

Our Ambitions for Pupil Premium Children

- At St. Bernadette's it is our aim that children of all ages who are eligible for Pupil Premium consistently achieve higher than their peers within school and nationally.
- We aim to ensure that teaching and learning opportunities meet the needs of all pupils.
- We ensure that appropriate provision is made for pupils who belong to vulnerable groups. This specifically includes ensuring that the needs of socially disadvantaged pupils are addressed.
- In making provision for socially disadvantaged pupils, we recognise that not all pupils who are eligible for free school meals, (or have been eligible in the last 6 years) are socially disadvantaged.
- We also recognise that not all pupils who are socially disadvantaged are registered or qualify for free school meals. We therefore allocate Pupil Premium funding to support any pupil or groups of pupils that the school has legitimately identified as being socially disadvantaged.
- Pupil Premium funding will be allocated following annual needs analyses which will identify priority classes and groups.

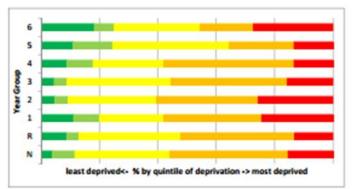

This is calculated based on pupil postcodes as recorded in the Jan 2015 school census and the nationally published 2010 IMD. Each pupil's postcode is assigned to the Lower Super Output Area (LSOA) which it is in. Each LSOA has an index of multiple deprivation (IMD). The IMD for the school is calculated as an average of the individual pupils deprivation scores. IDACI is the Income Deprivation Affecting Children Index and is calculated in the same manner as the IMD score.

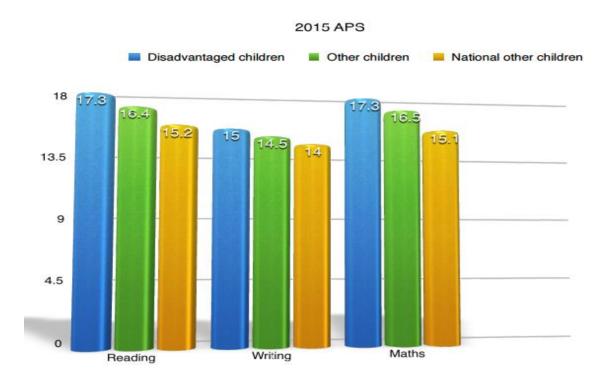

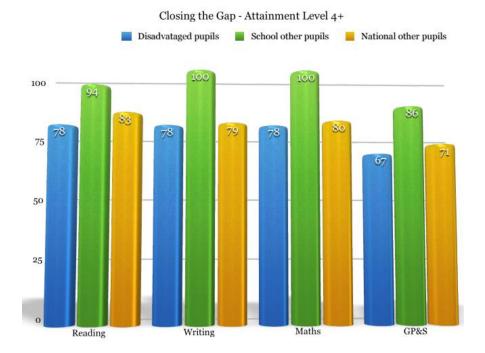
Pupil Premium children have a slightly lower attendance than non-pupil premium children. However the authorised absence figure is reduced slightly from 4% in 2013/2014.

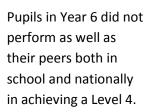
Key Stage 1 Results 2015



Overall average point score shows that children in receipt of pupil premium in Year 2 outperformed their peers both in school and nationally.

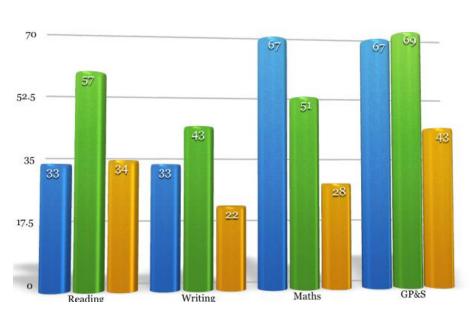
Key Stage 2 Results 2015

At the higher levels however pupils achieved well outperforming both peers in school and nationally in maths. For the other subjects they were either in line with national or above.

The St. Bernadette's Pupil Premium Guarantee

We have made a guarantee that we will invest our Pupil Premium Grant to make the maximum possible impact on the achievements of those students who qualify for this. Our guarantee for every qualifying child will include:

- A Pupil Premium Champion
- Guaranteed intervention when necessary
- Pastoral Support
- Subsidies
- Intensive Tracking and Monitoring
- Resources and training for staff to overcome barriers to learning

In creating our action plan for our funding use this financial year we have refered to the Sutton Trsut Education Edowment Fund (EEF) Teaching and Learning Toolkit. This is an accessible summary of educational research which provides guidance for teachers and schools on how to use their resources to improve the attainment of disadvantaged pupils. We have used this to evaluate how successful each of our strategies is in pursuit of our intended outcomes.

Average impact is estimated in terms of the additional months' progress you might expect pupils to make as a result of an approach being used in school, taking average pupil progress over a year as a benchmark.

In the financial year 2015/2016 St. Bernadette's received $\pounds 57,040$ in Pupil Premium Grant. The following plan sets out how we aim to meet our guarantee.
